##### Arising on Minute 1- Carter's Farm Barns

REPORTED:

## 7. PLANNING MATTERS

S/4498/19/FL – Consultation- Replacement dwelling (alternative design to S/2009/15/FL and S/2612/17/VC)- Mobile Home, Mill Green Meadow, Mill Green, CB21 4QZ

RESOLVED: following detailed discussion of the application with the applicants, who responded to questions from members on the application and its background and provided a point-by-point response from their agent to the redacted objections dated 20.1.20 on the planning portal, to inform South Cambs District Council that the Council supported the application and had no material planning objections to it, while wishing to ensure:

(a) that suitable arrangements are made to ensure that the ditch into which the clean water overflow from the sewage plant for the property will outfall is regularly maintained by local residents to avoid flooding;

(b) that the condition that the existing mobile home is demolished before the new residence is occupied is strictly adhered to in order to preserve the character of the location.

## 8. NOSTERFIELD END “LAY-BY”

RESOLVED: that the Chair write to the owner of the land adjacent to the “lay-by” on the north side of Haverhill Road, Nosterfield End, seeking his support for proposals to improve the site to make it less attractive as a dumping ground and location for dubious activity.
