## 6. DISTRICT AND COUNTY COUNCILLORS' REPORTS

RECEIVED: Nov 2022 (previously circulated to Councillors)

The Cambridge City Access Consultation closing date is 23/12/22, HB again encouraged everybody to submit their opinions via the consultation. It was confirmed that the link would be posted in the Village's whatsapp group again to make sure everyone has their say.

There is also a Roadshow at Linton Village College covering the above consultation on Tues 6<sup>th</sup> Dec.

There is a renewed push for volunteers to host Ukraine refugees, anybody who can help should contact the South Cambridgeshire District Council.

LHI bids are still open and the deadline is in Jan 23.

The Boundary commission has a current proposal to move Shudy Camps and other local villages into a different district (From South East to South), which would affect who is our local MP and this is currently open for public consultation.

Stagecoach has reinstated some of the services recently cut after a barrage of complaints, there are still issues with the app not showing some of the services especially the X13 and services are still being cancelled but some of the problems have been alleviated.

HB made the parish council aware of a Bio Plant on the Suffolk / Cambridge bounder who will be applying for planning in the near future. The main issue is the smell and increased traffic on the A1307.

## 8. PLANNING MATTERS

- i) Mill Green Meadow, Mill Green: 22/04259/S7 Variation of condition
   It was reported that this application has now closed and permission has also been granted
- ii) Park Lodge New Road Shudy Camps: 22/04450/FUL Replacement Dwelling

  The council supports the application and only point to raised is the parking of works vehicles to be off the public highway during the construction.
- iii) The Oaks, Blacksmiths Lane: 21/02235/FUL Appeal: Demolition of existing dwelling and industrial buildings and erection of 2 x 3 bed bungalows and associated garages and alteration of access
  - The previous submission for this site was circulated to the councillors prior to the meeting and it was agreed that they was no change in stances and the parish council still supports the application
- iv) Shardelows Farm, Mill Green: 22/05062/PRIOR Timber building for storage of equipment

This is prior approval application, so no comment can be made, so this has just been noted.

## 9. HIGHWAYS AND RELATED MATTERS

#### i) Jubilee Green

SP has gained 7 more signatures to confirm the village green prior use, so SP will now progress the application to the next stage and contact Open Space with the evidence collected.

The tree around the green were also discussed and there was some concern that they could fall into the road and powerlines. So it was decided that AK would contact a tree surgeons for advice on the treatment and report back at the next meeting

## ii) LHI Bid

The application for 22/23 has been submitted online by SK, the deadline is the end of Jan, so it will be early Spring 2023 when any feedback is received.

#### iii) Overhanging Trees on Blacksmith Lane

SK has yet to contact the owners of the Mews in the park, JP will forward the previous letter to SK and she will deliver by hand.

It was noted that the trees will need to be trimmed between the months of November and February before birds nest in the branched which stops any work being carried out.

## iv) Lorry Traffic through the village

HB confirmed that council are unable to restrict any movement on the public highway by the lorries. It was also confirmed that the damage caused by the vehicles at Nosterfield End will be repaired and if this doesn't solve the problem, the council will see what else can be done.

## v) House Locator Plan

SP looked into the sign and it would be in the region of £200 but this would not include any fixtures or fitting costs. The main issue with the sign would be where to locate it for it to be most effective, therefore the parish council will not pursue the sign any further at this current time.

# vi) Bus Stop issue in Main Street

Mr Bagley contacted the parish council during Nov 22, after an encounter with another resident when getting off a local bus, the other resident is reported to have acted very aggressively towards Mr Bagley. Following the encounter Mr Bagley contacted the police who have reported the incident and has informed Mr Bagley to call 999 in the future if anything similar happens.
