1. OPEN FORUM

It was noted that the lorries have started travelling through the village again, causing more damage to the roads and verges. HB suggested that the Highway Department could contact the company that own the lorries in writing, SCPC will mention this issue at the forthcoming joint parishes meeting when Bradley from the Highways Department will attend

HB will also confirm if the Enforcement officers have visited the site in Castle Camps as mentioned at the Nov meeting.

It was also noted that the application for the Lake in Castle Camps has been denied and the site needs to be returned to its former condition by Mar 23.

6. DISTRICT AND COUNTY COUNCILLORS' REPORTS

RECEIVED: Dec 2022 and Jan 23 (previously circulated to Councillors)

The local plan is moving forward to the next step, but due to the growth in the area being much higher than expected, they are now looking for a further 8000 houses, which could mean another new town and given the high employers in the south of the county (Babraham Institute and Welcome trust) the new town may be found in this area. Another issues in this area is the water supply which is at its capacity therefore other water sources will need to be found.

The 'Making Connections Consultation' has now closed and there was very good feedback, around 15% of the population.

Due to recent change from the Environment Agency, domestic sofas and upholstered chairs can no longer be disposed at landfill but now have to be incinerated. The county council have yet to source a supplier of this service so from the 1st Jan 2023 the council will not be able to dispose of soft furnishings but hopefully a solution will be found very soon.

Also on the same note Defra will required food waste to be collected separately from garden waste in the future, so this will impact on bin collection at some point.

It was confirmed that there was a data breach at Cambridge Water but is unsure how this has been communicated to the effected customers.

8. PLANNING MATTERS

- Shardelows Farm Mill Green Shudy Camps, 22/05000/FUL : Retention of Existing Highway Access to/from the existing agricultural barns and fields, and new timber post and rail fence.
 It was reported that this application has now closed and no comments were submitted by the Parish Council as the closing date was not extended beyond the end of Dec 2022.
- ii) Riverdale Main Street Shudy Camps, 22/04413/HFUL : Detached single storey residential annex and extension of residential garden boundary

The parish council does not support this application on the following grounds.

- The plans submitted are very vague with no details of water supply, drainage or sewage. They also make no reference to the parking or access route from the highway
- The proposed property will be very visible from the road and the style is not in keeping with other properties in the immediate area

• The size of the annex is a cause of concern (both in terms of the overall dimensions and the amount of accommodation – namely 2 bedrooms and 2 bathrooms) and also its closeness the boarder of the property, the adjacent stream (which holds a substantial level of water in heavy rain) and road side

- The site plan doesn't show existing out buildings which already cover a substantial area of the existing plot
- This application is subsequence to a recent application which has already extended the main property substantially

iii) Mill Green Meadow, Mobile Home Mill Green Shudy Camps, : 22/05512/CL2PD : Certificate of lawfulness under S192 for the development of the site in accordance with Planning approval ref. 22/04259/S73

This application was only for information and no comments are to be registered

9. HIGHWAYS AND RELATED MATTERS

i) Jubilee Green

SP has completed the application and both the Clerk and the Chair signed the forms and this was witnessed by James Gordon in his capacity as an ex-Shudy Camps Parish Councillor and Solicitor
