6. DISTRICT AND COUNTY COUNCILLORS' REPORTS

New Bin collection days as of September 19th, we will be getting a new bin collection day – which, for most in our area, will be changing from Monday to Wednesday each week.

The congestion charge is ongoing, there is much disagreement within the council on the plans and the deadline for funding from the government is fast approaching (end of 2023)

The works to the A1307 continues and the work on the new roundabout at Bartlow Road, Linton junction are progressing. To complete these works there will have to be 2 weekend closures of the A1307 at the end of September/beginning of October. Once this work has been completed the roundabout will be able to open and there won't need to be any further road closures at this junction.

10. Highways and Related Matters

- Stackyard
There have been no further communication since the phone call in July, the parish clerk will contact the enforcement officer for an update on the case.

- Jubilee Green Application
SP has received another email in the last few weeks confirming the previous searches came back ok but they need to do additional searches on the land.
- LHI decision
HB confirmed that we should have received some communication on the project, HB will follow this up and cc in the parish clerk.

- Community Automated External Defibrillators fund
This fund is available to provide Defib units for the local community, the clerk submitted an interest and they will notify us when applications open.
- Road Surfaces
A resident from the village raised the point that the paths have been resurfaced in Shudy Camps recently but the roads which are in a very bad state of repair have been missed. HB also received emails from other residents on the same issue.
The highways departments justification for the repairs are that the repairs were carried at this stage prior to further degradation, this meaning the repairs in longer term are cheaper, they also added that the Tarmac used is of a lower grade to that used on the roads.
The road repairs and full resurfacing in SC are in the budget for Financial Year 25/26 and Main Street is on the list among others, HB will confirm the others listed.
- Drains at Nosterfield End
Flooding at Nosterfield End has been raised again by the residents, HB suggested contacting the Flooding Department which have been helpful sorting other local flooding issues, HB will forward the contact details to the clerk

- Gigaclear Ultra Fast Fibre
Gigaclear have approached the Clerk about possible upgrade to Fibre in the Shudy Camps and is keen to present to the councillors. SP indicated prior to the meeting that he would be more than happy to meet GC and given his technical knowledge this was

agreed. John Haine formerly of the parish council is also keen to be involved in the process as he has been a key member in previous attempts to upgrade the villages' communication links. The clerk will relay this information to the relevant parties
