Other points to note was that the budgets for 24/24 are being finalised and it looks like both the District Council and County Council will raise the Council Tax by the maximum amount which is £5 and 4.9% respectively. Plus the mayor for the Cambridge and Peterborough Authority now has his own tax which will be added to the Council Tax this will be in the region of £10 and will be used to fund Public Transport which is within the mayor remit.

The A1307 is now fully open with all work near Linton complete. No other roadworks are due on the A1307 in the immediate future.

- i) 23/04023/HFUL Proposal: Erection of a 4bay garage and upgrade to existing boundary fence : Cedar View Mill Green Horseheath.
Original application deadline Dec 23 (no submission). Revised application rec'd Jan 24 and new deadline 12/2/24 (New location)

The SCPC stance on the application is Neutral : The concerns for the project is the drainage for the proposed site. There does appear to have been more standing water outside the property/highway since the groundworks have started. Therefore SCPC just want to make sure that the drainage and soak away is sufficient and will not impact the highway or other local properties.

- Additional Defib Unit - Main Street
JP contacted a local electrician (PH Electrical) to ask about the possibility of locating a Defib unit in the Main Street Telephone Box (electric supply needed). The contractor is more than happy to quote but asked JP to contact the National Grid to confirm if it is an unmetered supply. JP will aim to do this before the next meeting.
