1. OPEN FORUM

There were 2 issues raised in respect of the footpaths around the village by a resident.

The footpath in the meadow behind the Village Sign off Main Street: the slope is very slippery and making it impassable for some. It was requested if a hand rail could be put up to assist walking this section of path. PM will look into this and contact both the land owner and the 'Footpaths' department at the council to see if anything can be arranged.

The steps next to Granary Cottage are also in a bad state of repair (next to the rail). PM will contact the landowner and see if some repair can be carried out.

The two planning applications for biodigesters in our area, Acorn in Haverhill and Streetly End Farm in West Wickham, are edging closer to a decision. Both projects have been asked for additional information and a decision is expected in the summer later this year.

Both the County and District Councils have set their budgets for the forthcoming municipal year. Both opted to raise Council Tax, which means, in real terms, this equates to:

County Council – increase of 4.99% on band D properties - £76.98 per year South Cambridgeshire District Council - £5 per year on Band D

8. PLANNING MATTERS

- i) 23/04023/HFUL Proposal: Erection of a 3 bay garage and upgrade to existing boundary fence: Cedar View Mill Green Horseheath.
 Original application deadline Dec 23 (no submission). Revised application rec'd Jan 24, submitted 09/02/24 and granted permission 14/02/24
- ii) 23/02626/CONDB: Bangs Close, Shudy Camps awaiting decision

 This planning application was rec'd in respect of information only but was a revision of 23/02626/CONDA (Condition 3 Drainage) which was previously rejected and the revision should have been resubmitted and approved prior to any building work being started.

The revision submitted includes a shallow soak away on site and revised pipe in the bridge over the stream.

During the recent heavy rain, water from the site and stream which has a bottle neck at the bridge caused a substantial increase in water flowing into Main street

and also raised the issues of possible flooding and properties close by. It also washed a lot of debris in to the drains, blocking them.

AK will contact the planning department to raise the SCPC concerns of the water flow and drainage from the site and the recent events detailed above. Plus get an update from the compliance team who have or will be visiting the site.

- Flooding Nosterfield End

There was an onsite meeting 28th Feb which was attended by Angela Sills, her son and the tenant farmer, as was 2 representatives from the county council, 1 from Highways and 1 from flooding. Paul Malins Parish Councillor, Henry Batchelor and 2 residents.

The outcome of the meeting:

- The landowner has agreed to clear the ditches
- The Council agreed to jet the drains
- Once this has been done, they will use mini CCTV cameras to check the drainage pipes and culverts under the road to decide if repairs need to be undertaken
- In order to do this, the council will need to shut that stretch of the road, the application process to do this can take 8-10 weeks.
- They will notify the Sills of the date, so that they can take advantage of the road closure to complete the ditch clearing

Delivery of the device is yet to be confirmed.

Plus one of the new posts installed near Parkway is to be repositioned due it proximity to a telegraph pole (making hedge maintenance impossible)

The proposed additional unit in the Main Street Telephone Box is still in the planning stages with the Electric source still tbc and condition of the box covered below

Telephone Boxes

Main Street: SCPC has been made aware by a resident that the telephone box is no longer water tight causing water damage to the contents. It was proposed to clear the contents out of the phone box, carry out any repairs needed and at the same time liaise with the electrician the confirm if there is a source in the phone box and possibly investigate the light which no longer seems to work.

It was been noted the Telephone Box is being used as local Library, this has raised concerns that the door is opening onto the road. SCPC has not been approached with regards to its current usage and if it is safe as it was proposed to relocate it away from the highway close to its current location. The clerk will investigate further.
